RULES

“the Event” - the magic market known as the North West Magic Mart ; this is a one-day market held by The Order of the Magi, for those who have goods to sell and prospective buyers to meet.

“IWHC” - The Irish World Heritage Centre

“the Organiser” – those members of the Council of the Order of the Magi who have organised the North West Magic Mart

“The Magi” - The Order of the Magi

“Trader” - a person who takes a pitch at the North West Magic Mart

The Trader, in accepting a pitch, agrees to accept and abide by the Rules set out below.

1. The Trader must have both booked, and paid the fee for, his/her pitch by 12th May 2007. Any later bookings and/or payments will be accepted only at the discretion of the Organiser.
2. Each Trader will have a designated trading area and will be supplied with a table top/supports; most of the tabletops measure approximately 1.8M x 0.6M (6 ft x 2 ft).
3. a) During the Event, trading will be between 10.00a.m. and 3.00p.m. The Trader is expected to have set up his/her stall by 10.00a.m. The IWHC has agreed to provide access from 9.00am.
b) Other than in exceptional circumstances, the Trader should not dismantle his/her stall until 3.00p.m.
4. Throughout the Event, the Trader is responsible for the care and security of his own goods and stall. Either he, or someone on his behalf, should be present throughout the day. Neither the Organiser, nor the Magi will accept any responsibility for the Trader’s property either before, during or after the Event.

The Trader’s Stall

5. a) The Trader must take reasonable steps to ensure the safety of himself/herself and others throughout the Event. He/she is expected to behave in a considerate manner by not causing or permitting a nuisance, obstruction or potential hazard, such as a tripping risk.
b) The Trader’s stall and the area around it should be kept tidy and free from rubbish. The Trader is responsible for removing all his/her own rubbish after the Event.

The Sale of Goods

6. a) The Trader is responsible for answering a buyer's questions and neither the Organiser, nor the Magi can accept any responsibility for information provided by the Trader about goods for sale, by any means, to a prospective purchaser.
b) All negotiations for the sale of goods are entirely a matter between the Trader and a purchaser.

Articles for Sale

7. a) No goods must be sold, offered for sale or displayed for sale which infringe, or appear likely to infringe, any copyright, trademark, or similar.
b) No mains- powered electrical goods may be sold, offered for sale or displayed for sale, unless they either :-
i) have been bought, as new, in the E.C. within the previous 12 months (proof of purchase must be available for inspection)
or
ii) carry an E.C. Electrical Safety Certificate, being no more than 12 months old.
c) No article intended for human consumption may be sold, offered for sale or displayed for sale. There is no objection to such an article being available for, or used for, demonstration purposes only.
d) Offensive articles must not be sold, displayed for sale or offered for sale, neither must such articles be available for, or used for demonstration purposes. The Organiser may, at their discretion, require any article, deemed to be offensive, to be removed.
e) No livestock may be brought into the IWHC other than for demonstration purposes.
